

NOTIFICATION

Annual assessment of the students of Veda Bhushan (1st to 5th Year) and Veda Vibhushan 1st year for the academic session 2020-21.

All the Veda Pathashalas and the Guru Shishya Parampara (GSP) Units and the external students are hereby informed that keeping in view the situation arising out of the COVID-19 pandemic in the country and also the future of the students, the Examination Committee of the Pratishtan has decided to award marks on the assessment formulae and to declare the annual result of the students of Veda Bhushan (1st to 5th year) and Veda Vibhushan (1st) year.

1. For Veda Bhushan 1st year students, the respective Gurus will assess the students only for the papers on Veda as per the proforma. Pratishtan will award the minimum passing marks in modern subjects.
2. For Veda Bhushan 2nd year students to Veda Vibhushan 1st year students, the respective Gurus will assess the students in Veda as well as in other modern subjects and award marks, as per proforma. The Gurus will remain responsible for the assessment and marks awarded.
3. In case any student/Guru is not satisfied with the marks awarded to the students, a special examination will be conducted for those students who apply on his own or through the Guru/Pathashala for appearing in such examination, after the pandemic situation in the country is over and the Govt. of India/local administration relaxes the restrictions. The students who appear in such special examinations will have to accept the marks secured in such re-examinations as final even if they are not satisfied with the marks obtained in re-examination.
4. The proforma and other details of the students studying in the Veda Pathashalas and GSP Units as well as the external students can be downloaded from the website of the Pratishtan using the Login ID and Password. Filled in proforma may be submitted to the Pratishtan in its e-mail ID session21@msrvvp.ac.in within 10 days i.e. before 30th May, 2021. While uploading on e-mail, the size of the proforma should not exceed 500kb. In case it exceeds the prescribed size, the same can be uploaded separately. Any difficulty/technical glitch may be immediately reported to Pratishtan through only the e-mail mentioned above. No discussion on telephone will be entertained.

In compliance of the directives of the Ministry of Education, Govt. of India, holding of examination or any other way for Veda Vibhushan 2nd year (7th year) which is equivalent of 12th Standard is still under consideration. Notification in this regard will be issued separately in the website of the Pratishtan.

While awarding marks to the students in the proforma, the Gurus are advised NOT to call the students to the Pathashalas/Units. Gurus should fill up the proforma based on the students' level of study as known/assessed by them. Only in exceptional cases, the Gurus may interact with the students on telephone/video call in this regard.
