It is to inform you that Veda Bhushan and Veda Vibhushan courses conducted by Maharshi Sandipani Rashtriya Veda Vidya Pratishthan, Ujjain have already been recognized as equivalent to Prajna/Purva Madhyama and Vishard/Uttar Madhyama courses, respectively, of this university for the purpose of admission to Vishard/Uttar Madhyama and Shastri courses, respectively vide Reso. No. 24 of Academic Council dated 27.11.2012 (Copy enclosed). Further, the Board of School Education, Haryana, Bhiwani has also recognized Purva Madhyama and Uttar Madhyama courses of this university as equivalent to 10<sup>th</sup> and 12<sup>th</sup> examination respectively with the condition that the candidate should have passed at least five subjects including two subjects other than language subject.

Considered the following recommendations made by the Equivalence Committee through circulation:


1. That Veda Bhushan and Veda Vibhushan courses conducted by Maharshi Sandipani Rashtriya Vedavidya Pratisthan, Ujjain be recognised as equivalent to Prajana/Purva Madhyama and Visharda/Uttar Madhyama courses, respectively, of this University for the purpose of admission to the Visharad/Uttar Madhyama and Shastri courses, respectively;

4. That Pharm. D. Course conducted by the Institute approved by the Pharmacy Council of India be recognised as equivalent to M.Pharm. Course of this University for registration to Ph.D. Programme.
